As the investment adviser to the Funds, AWM holds sole voting and investment power over 799,427 of Common Stock of the Issuer (the Shares) held by QP, 298,979 Shares held by CAYMAN and 248,122 Shares held by PE.
- (2) Austin W. Marxe (Marxe), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM.
