Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 20,358,243 shares or 6.369% of the Common Stock outstanding of NUANCE COMMUNICATIONS INC ("the Company") as a result of

acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of NUANCE COMMUNICATIONS INC owned by the investment companies at December 31, 2012 included 2,443,585 shares of Common Stock resulting from the assumed conversion of \$47,565,000 principal amount of NUANCE COMM CONV 2.75% 8/15/27 (51.3736 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of NUANCE COMMUNICATIONS INC owned by the investment companies at December 31, 2012 included 2,998,883 shares of Common Stock resulting from the assumed conversion of \$96,860,000 principal amount of NUANCE COMMUN CONV 2.75% 11/31 (30.961 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of Fidelity, and the funds each has sole power to dispose of the 20,358,243 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d, Chairman of FMR LLC, has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Strategic Advisers, Inc., 82 Devonshire Street, Boston, MA 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, provides investment advisory services to individuals. As such, FMR LLC's beneficial ownership includes 4,756 shares, or 0.001%, of the Common Stock outstanding of NUANCE COMMUNICATIONS INC, beneficially owned through Strategic Advisers, Inc.

Pyramis Global Advisors, LLC ("PGALLC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 579,900 shares or 0.181% of the outstanding Common Stock of NUANCE COMMUNICATIONS INC as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning

such shares. The number of shares of Common Stock of NUANCE COMMUNICATIONS INC owned by the institutional account(s) at December 31, 2012 included 579,900 shares of Common Stock resulting from the assumed conversion of \$18,730,000 principal amount of NUANCE COMMUN CONV 2.75% 11/31 (30.961 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of PGALLC, each has sole dispositive power over 579,900 shares and sole power to vote or to direct the voting of 579,900 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Pyramis Global Advisors Trust Company ("PGATC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 93,879 shares or 0.029% of the outstanding Common Stock of the NUANCE COMMUNICATIONS INC as a result of its serving as investment manager of institutional accounts owning such shares. The number of shares of Common Stock of NUANCE COMMUNICATIONS INC owned by the institutional account(s) at December 31, 2012 included 26,714 shares of Common Stock resulting from the assumed conversion of \$520,000 principal amount of NUANCE COMM CONV 2.75% 8/15/27 (51.3736 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of NUANCE COMMUNICATIONS INC owned by the institutional account(s) at December 31, 2012 included 31,890 shares of Common Stock resulting from the assumed conversion of \$1,030,000 principal amount of NUANCE COMMUN CONV 2.75% 11/31 (30.961 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of Pyramis Global Advisors Trust Company, each has sole dispositive power over 93,879 shares and sole power to vote or to direct the voting of 35,275 shares of Common Stock owned by the institutional accounts managed by PGATC as reported above.

FIL Limited ("FIL"), Pembroke Hall, 42 Crow Lane, Hamilton, Bermuda, and various foreign-based subsidiaries provide investment advisory and management services to a number of non-U.S. investment companies and certain institutional investors. FIL, which is a qualified institution under section 240.13d-1(b)(1)(ii), is the beneficial owner of 2,800,013 shares or 0.876% of the Common Stock outstanding of the Company.

Partnerships controlled predominantly by members of the family of Edward C. Johnson 3d, Chairman of FMR LLC and FIL, or trusts for their benefit, own shares of FIL voting stock. While the percentage of total voting power represented by these shares may fluctuate as a result of changes in the total number of shares of FIL voting stock outstanding from time to time, it normally represents more than 25% and less than 50% of the total votes which may be cast by all holders of FIL

voting stock. FMR LLC and FIL are separate and independent corporate entities, and their Boards of Directors are generally composed of different individuals.

FMR LLC and FIL are of the view that they are not acting as a "group" for purposes of Section 13(d) under the Securities Exchange Act of 1934 (the "1934" Act) and that they are not otherwise required to attribute to each other the "beneficial ownership" of securities "beneficially owned" by the other corporation within the meaning of Rule 13d-3 promulgated under the 1934 Act. Therefore, they are of the view that the shares held by the other corporation need not be aggregated for purposes of Section 13(d). However, FMR LLC is making this filing on a voluntary basis as if all of the shares are beneficially owned by FMR LLC and FIL on a joint basis.

FIL has sole dispositive power over 2,800,013 shares owned by the International Funds. FIL has sole power to vote or direct the voting of 2,704,513 shares and no power to vote or direct the voting of 95,500 shares of Common Stock held by the International Funds as reported above.
