 - (6) Restricted stock units granted to reporting person on 02/19/18, 100% of the award is vesting on 02/19/21.
 - (7) Phantom Stock Units held for the benefit of reporting person as of February 28, 2018 based on the value of Humana common stock on a 1-for-1 basis, under the Humana Retirement Equalization Plan. The ending number of units reflects normal fluctuation due to changes in stock price.
