On November 16, 2006, Greg D. Kerley, Executive Vice President and Chief Financial Officer of Southwestern Energy Company (the "Company"), will make a presentation at the Bank of America 2006 Energy Conference in Key Biscayne, Florida. The presentation will include year-to-date operating information relating to the Fayetteville Shale play and updated guidance regarding the Company's projected net income, operating income, earnings per share, net cash provided by operating activities before changes in operating assets and liabilities ("Net Cash Flow") and earnings before income taxes, depreciation, depletion and amortization ("EBITDA") for fiscal year 2006. Net Cash Flow and EBITDA are non-GAAP measures that are reconciled on pages 31 and 32 of the presentation. A copy of the presentation is furnished herewith as Exhibit 99.1.
