- (1) Grant of Incentive Stock Options to acquire 3,000 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Stock Option Plan of 2000. Options become exercisable with respect to 444 shares on 02/22/2006 and in 6 annual increments of 426 shares beginning on 02/22/2007 at an option price of \$27.75. These options expire on 02/22/2015.
- (2) Grant of Incentive Stock Options to acquire 7,000 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Incentive Stock Option Plan of 2000. Options become exercisable with respect to 1,000 shares on 10/18/2006 and in 6 annual increments of 1,000 shares starting on 10/18/2007 at an option price of \$26.99. These options expire on 10/18/2015.
- (3) Grant of Incentive Stock Options to acquire 2,400 shares of Bar Harbor Bankshares common stock under the Bar Harbor Bankshares (and subsidiaries) Incentive Stock Option Plan of 2000. Options become exercisable with respect to 800 shares on 01/23/2008 and in 2 annual increments of 800 shares starting on 01/23/2009 at an option price of \$33.00 per share. These options expire on 01/23/2016.
