- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 4,836 units were acquired at prices ranging from \$52.07 to \$67.80. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 380 units were acquired at prices ranging from \$52.07 to \$66.52. These transactions are exempt under rule 16a-11.
- (3) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 119 units were acquired at prices ranging from \$52.07 to \$67.80. These transactions are exempt under rule 16a-11.
- (4) Options vest at a rate of 33% per year on each anniversary date, beginning on February 26, 2014.
- (5) Options vest at a rate of 33% per year on each anniversary date, beginning on March 27, 2013.
