Three-for-Two Stock Split

Overland Park, Kan., May 9, 2002 -- Applebee's International, Inc. (Nasdaq:APPB) announced today at its Annual Meeting of Stockholders that it has declared a three-for-two stock split, to be effected in the form of a 50 percent stock dividend, payable June 11, 2002. Shareholders of record as of May 24, 2002 will receive one additional share for every two shares held on that date. Cash will be paid in lieu of fractional shares.
