Distribution of shares of common stock occurs six months after a director's service on the Board terminates, or upon a later date or dates designated by the director if he or she has elected to further defer receipt of shares pursuant to the Company's Deferred Compensation Plan for Non-Employee Directors.
- (2) Included are an additional 270.56 deferred stock units credited since February of 2007 through dividend reinvestment.
