Kewsong Lee, a Director of the Issuer, is a General Partner of WP, a Managing Director and Member of WP LLC and a beneficial owner of certain shares of capital stock of WP VIII Bermuda Ltd. and WPIP Bermuda Ltd. Other than 150,199 Common Shares, 13,271 of which were granted to and are directly owned by Mr. Lee in consideration of his service as a Director of the Issuer, the Warburg Pincus Entities own 588,747 Common Shares. Mr. Lee may be deemed to have an indirect pecuniary interest (within the meaning of Rule 16a-1 under the Securities Exchange Act of 1934) in an indeterminate portion of the shares owned by WP VIII Bermuda, WPIP Bermuda and WPIP Netherlands I. Mr. Lee disclaims beneficial ownership of all shares owned by the Warburg Pincus Entities, except to the extent of any pecuniary interest therein.

(3) On December 8, 2009, WPIP Bermuda Ltd. sold 239,630 Common Shares on the open market.
