(1) Restricted stock units ("RSUs") convert into common stock on a one-for-one basis.

As of August 14, 2015, FWW B.V. ("FWW") directly owns 119,024,000 shares of Frank's International N.V.'s common stock, par value Euro 0.01 per share (the "Common Stock"). FWW is controlled by Donald Keith Mosing, as managing director. Mr. Mosing is also a party to that certain Voting Agreement, dated July 22, 2013, by and among Ginsoma Family C.V., FWW, Mosing Holdings, Inc. and certain other parties thereto. Additionally, Mr. Mosing is a shareholder of FWW. Accordingly, Mr. Mosing may be deemed to beneficially own shares of Common Stock owned by FWW. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by FWW, except to the extent of his pecuniary interest therein.

(2) On August 14, 2013, the reporting person was granted 1,136,364 RSUs, vesting 20% per year on the anniversary of the grant over the first three years, with the remaining 40% vesting on March 31, 2017.

(3) Also consists of 264,423 RSUs that will vest ratably in three annual installments beginning on February 23, 2016.
