ACPGP, ACA, Robert Atchinson and Phillip Gross disclaim beneficial ownership of the reported securities except to the extent of their pecuniary interest therein.
- (2) The Preferred Stock to which this note relates is convertible at any time, at the option of the holder, into approximately 1.25 shares of Common Stock. The conversion right of the Preferred Stock to Common Stock has no expiration date.
