The name of the issuer is Aerie Pharmaceuticals, Inc. (the "Company").

By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934 (the "Act"), ACPGP and ACA may be deemed to beneficially own the shares owned by ACP.
