

Item 8.01 Other Events.

On July 17, 2017, BorgWarner Inc., a Delaware corporation (the “Company”), announced that it had entered into an agreement to acquire Sevcon, Inc., a Delaware corporation (“Sevcon”), in a transaction with an enterprise value of approximately \$200 million. Consummation of the transaction is subject to specified closing conditions, including receipt of the approval of Sevcon’s equityholders and receipt of required competition law approval.
