of, and/or voting and dispositive power over: (i) 190,680 shares of Class A Common Stock held by Ms. Gershwind; (ii) 3,777,094 shares of Class B Common Stock, par value \$.001 per share, that are convertible into shares of Class A Common Stock on a one-to-one basis (the "Class B Common Stock"), held by Ms. Gershwind; (iii) 946,246 shares of Class B Common Stock held by the Marjorie Diane Gershwind 1994 Qualified Fifteen Year Annuity Interest Trust, of which Ms. Gershwind is a settlor; and (iv) 156,142 shares of Class B Common Stock held by the Marjorie Diane Gershwind 1998 Qualified Seven Year Annuity Trust, of which Ms. Gershwind is a settlor; Ms. Gershwind disclaims beneficial ownership of all the shares of Class B Common Stock owned by the Marjorie Diane Gershwind 1994 Qualified Fifteen Year Annuity Interest Trust and all the shares of Class B Common Stock owned by the Marjorie Diane Gershwind 1998 Qualified Seven Year Annuity Trust.
