As of February 13, 2002, began 10-year distribution, per director's election. Shares distributed as of February 13, 2002 represent about one-tenth of the total 18,187 shares to be distributed. These shares have been previously reported on Section 16 filings. The descending balance will continue to be held by the Trust through the 10-year distribution period.
  
- (3) Adjusted to reflect the 1,819 share distribution in Footnote (2), now held directly.
