Item 1.01 Entry into a Material Definitive Agreement

On October 1, 2004, Universal Electronics Inc. (Universal) entered into an agreement with certain stockholders of SimpleDevices, Inc., a Delaware corporation (SDI), to acquire substantially all the outstanding shares of SDI s capital stock for a purchase price of approximately \$12.5 million, plus a possible performance-based payment of up to 65,842 shares of Universal unregistered common stock, tied to achieving certain future financial objectives.
