\$0.01 par value per share (the "Shares"), of Peak International Limited, a Bermuda exempted company with limited liability (the "Issuer"). This Amendment No.2 supplementally amends the initial statement on Schedule 13D, filed September 30, 2005 by the Reporting Persons (as defined below).

ITEM 1. SECURITY AND ISSUER.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

According to information filed by the Issuer with the Securities and Exchange Commission in its most recent quarterly report on Form 10Q, the number of Shares outstanding was 12,420,389 as of the close of business on February 7, 2006.

- (a) (i) Mound Fund, LP ("Mound") may be deemed to be the beneficial owner of 602,400 Shares, or 4.9% of the Shares outstanding.
 - (ii) GWA Capital Partners LLC ("GWA Capital Partners") may be deemed to be the beneficial owner of 702,400 Shares, or 5.7% of the Shares outstanding.
 - (iii) Mr. Guy W. Adams ("Mr. Adams") may be deemed to be the beneficial owner of 702,400 Shares, or 5.7% of the Shares outstanding.
- (b) (i) Mound may be deemed to have sole power to direct the voting and disposition of 602,400 Shares.
 - (ii) GWA Capital Partners may be deemed to have sole power to direct the voting and disposition of 702,400 Shares held for the accounts of Mound and GWA Master Fund, L.P. ("GWA Master Fund"), with respect to which GWA Capital Partners serves as general partner, and GWA Investments LLC ("GWA Investments"), with respect to which GWA Capital Partners serves as managing member.
 - (iii) Mr. Adams, in his capacity as managing member of GWA Capital Partners, may be deemed to have sole power to direct the voting and disposition of 702,400 Shares held for the accounts of Mound and GWA Master Fund, with respect to which GWA Capital Partners serves as general partner, and GWA Investments, with respect to which GWA Capital Partners serves as managing member.
- (c) Except as set forth in Annex A hereto, there have been no transactions effected with respect to the Shares by any of the Reporting Persons.
- (d) None.
