  - (1) The sale reported in this Form 4 was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on November 11, 2004. The trading plan was established to sell up to 28,607 shares of the Company's common stock. Portions of the shares may be sold on specified dates or any time the stock achieves certain pre-arranged minimum prices and may take place beginning on January 3, 2005 and ending on February 15, 2005, unless sooner terminated. The Reporting Person will have no control over the timing of any sales under the plan and there can be no assurance that the shares covered by the plan actually will be sold. The Reporting Person entered into the plan for personal tax and financial planning purposes and will continue to have a significant ownership interest in the Company.
  - (2) The total amount of securities beneficially owned includes: (a) 1,266 shares acquired through the Company employee stock purchase program; (b) 1,028 out of an original 35,000 shares of restricted stock granted 9/1/00, which is fully vested; (c) 24,982 shares acquired by the exercising of vested employee stock options; and (d) 5,096 shares of performance-based restricted stock

granted 2/2/04, of which 0 shares are vested.

- (3) This is an employee stock option grant that is fully vested.
