**MECHEL PLANS TO RESTART SHORTLY PRODUCTION AT VYARTSILYA METAL PRODUCTS PLANT**

**Vyartsilya, Russia December 20, 2004** Mechel announces that the fire that broke out in Vyartsilya Metal Products Plant on December 18 was completely extinguished the same day, with no injuries. Works are currently underway to restart production.

The fire destroyed about 1,500 square meters of production facilities. Currently work is underway to restart production. By December 23, 2004, several workshops will start operating normally. Repair works are scheduled to be completed before the end of January 2005, and production fully restored in the first quarter of 2005.

The fire was quickly localized and extinguished by the local fire fighting services with the assistance of the plant employees.

An investigation of the incident is underway. According to preliminary reports, the fire was caused by a short circuit in a transformer unit located on the plant's territory. The incident caused no interruption of the power and heat supply in Vyartsilya.
