- (2) Represents the accrual of additional LTIP Units upon the reinvestment of dividend equivalents earned on 10,156 unvested LTIP Units previously earned under a performance award granted on March 18, 2014. The additional units, like the units on which they were paid, will vest on January 1, 2016, subject to the continued employment of the reporting person through that date.
