Reporting Person acquired the shares upon automatic conversion of 3,062,743 shares of the Issuer's Non-Voting Series B Convertible Preferred Stock Reporting Person received on December 30, 2011 as compensation for services to the Issuer. The Non-Voting Series B Convertible Preferred Stock immediately converted into, on a 1 for 1 basis after giving effect to the a 1 for 700 reverse stock split of Issuer's outstanding common stock (the "Reverse Stock Split"), the Issuer's Common Stock upon the November 26, 2012 effective date of the Reverse Stock Split. Note, Issuer previously reported in error that Reporting Person owned 3,062,753 shares of the Non-voting Series B Convertible Preferred Stock. The correct number of shares should have been reported as 3,062,743.

Shares are owned directly by subsidiaries of CD International Enterprises, Inc. as follows: China Direct Investments, Inc. 2,216,020 shares and Capital One Resources Co., Ltd. 846,723. CD International Enterprises, Inc. is an indirect beneficial owner of the reported securities. See Note 1 above regarding error in number of shares reported.
