As reported in the Current Report on Form 8-K that TierOne Corporation (the "Company") filed with the Securities and Exchange Commission ("SEC") on October 14, 2009 (the "October Form 8-K"), in connection with an examination of TierOne Bank (the "Bank") which commenced after the Company filed its second quarter 2009 Form 10-O, the Office of Thrift Supervision, the Bank's primary regulator, directed the Bank to establish additional loan loss provisions for the guarter ended June 30, 2009.

As noted in the October Form 8-K, the Company intends to file an amended Form 10-Q for the quarter ended June 30, 2009 (including restated financial statements) as soon as practicable after management has completed its assessment of the examination. The Company requires additional time to complete this assessment and file the amended Form 10-O, which the Company must do before it can complete the financial statements and Management's Discussion and Analysis for its Form 10-Q for the quarter ended September 30, 2009 and its Form 10-K for the year ended December 31, 2009.
