- (2) Mr. Hubbell also holds 22,553 phantom stock units which are convertible on a 1 for 1 basis. This number includes 1,595 previously unreported phantom stock units accrued under the dividend reinvestment feature of the Plan. The shares attributable to the phantom stock units first become distributable upon the January 1 following the termination of service pursuant to earlier elections in accordance with the Plan terms.
