The shares were received by the reporting person as part of the Mirant bankruptcy settlement in exchange for Mirant debt previously held by him. As a result of Mirant's final settlement with Potomac Electric Power Company, excess reserved shares not issued in the settlement were distributed to other former Mirant creditors. On September 4, 2007, the reporting person received common stock as part of this supplemental distribution. Because the shares received by the reporting person were "acquired in good faith in connection with a debt previously contracted", their acquisition is not covered by Section 16(b).
