are paid on HP common stock. The number of derivative securities in column 5 includes 31.2 vested dividend equivalent rights and a de minimus adjustment of 0.8000 due to fractional rounding of the dividend equivalent rights.

- (5) On 12/10/10 the reporting person was granted 10,624 restricted stock units ("RSUs"), 5,312 of which will vest on each of 12/10/11 and 12/10/12. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
