## Explanation of Responses:

(1) The restricted stock units will vest in 50% installments at each of the first and second anniversaries of the grant date. Each unit represents a right to receive one share of Common Stock or an amount equal to the fair market value of the Common Stock underlying the unit on the vesting date. Payment may be made in cash, shares of Common Stock or a combination thereof.

(2) The restricted stock units will vest in installments of 50% at the second anniversary of the grant date and 25% at each of the third and fourth anniversaries of the grant date. Each unit represents a right to receive one share of Common Stock or an amount equal to the fair market value of the Common Stock underlying the unit on the vesting date. Payment may be made in cash, shares of Common Stock or a combination thereof.
