- This stock option was granted on December 2, 2008 and vests over four years. Subject to the optionee's continuing to provide services,
- (1) 25% of the shares subject to the option vested and became immediately exercisable one year after November 10, 2008, and 2.08% of the shares vest and become exercisable at the end of each monthly period thereafter.
 - (2) Each share of Common Stock shall be automatically converted into one share of Class B Common Stock immediately prior to the closing of the Registrant's initial public offering on March 29, 2010 and has no expiration date.
- Following the conversion of Common Stock into Class B Common Stock immediately prior to the closing of the Registrant's initial public offering on March 29, 2010, each share of Class B Common Stock will be convertible into one share of Class A Common Stock upon certain transfers and at the option of the holder. On the seventh anniversary of the closing of the Registrant's initial public offering (March 29, 2017), the Class B Common Stock and the Class A Common Stock will automatically convert into a single class of Common Stock.
