Unilever NV also announces that 136,905 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 56,073,763 Unilever NV ordinary shares in treasury, and has 1,658,653,937 Unilever NV ordinary shares in issue (excluding treasury shares).
