Unilever NV announces that on 2 May 2007 it purchased 822,489 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.257 and euro 22.398 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 48,572 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 63,149,690 Unilever NV ordinary shares in treasury, and has 1,651,578,010 Unilever NV ordinary shares in issue (excluding treasury shares).
