Unilever NV announces that on 30 May 2007 it purchased 200,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 22.106 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 36,196 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 69,935,368 Unilever NV ordinary shares in treasury, and has 1,644,792,332 Unilever NV ordinary shares in issue (excluding treasury shares).
