**DEREGISTRATION OF UNSOLD SECURITIES**

This Post-Effective Amendment No. 1 (the "Amendment") relates to the Registration Statement on Form S-8 filed with the Securities and Exchange Commission on September 27, 2001 (File No. 333-70290) (the "Registration Statement"), of BSQUARE Corporation (the "Company") pertaining to 96,000 shares (as adjusted to reflect the one-for-four reverse stock split effected on October 7, 2005) of the Company's common stock, no par value ("Common Stock"), authorized for issuance under the Company's 2000 Non-Qualified Stock Option Plan (the "2000 Non-Qualified Plan"). The Company has subsequently terminated the 2000 Non-Qualified Plan.

As a result of the termination of the 2000 Non-Qualified Plan, the offering of Common Stock thereunder, pursuant to the Registration Statement, has been terminated. In accordance with an undertaking made by the Company in the Registration Statement to remove from registration, by means of a post-effective amendment, any of the securities which remain unsold at the termination of the offering, the Company hereby removes from registration the 96,000 shares (as adjusted to reflect the one-for-four reverse stock split effected on October 7, 2005) of Common Stock registered but unsold under the 2000 Non-Qualified Plan pursuant to the Registration Statement.
