**Item 8.01 Other Events**

The New Jersey Board of Public Utilities (the BPU ), at its November 21, 2017 meeting, approved an extension of the deadline for filing PSE&G s distribution base rate case proceeding to February 1, 2018. The filing will now be based upon five months of actual data and seven months of forecasted data. PSE&G is required to file a distribution base rate case as a result of its Energy Strong Order from the BPU.
