#### Dear partners,

I have assured you that we will keep you informed about the next steps in our merger process, so I want to share a quick update.

Today we issued a press release with T-Mobile announcing that our companies have successfully completed the regulatory process with the Committee on Foreign Investment in the United States for our proposed merger.

We are pleased that the CFIUS process, which in this case included a review by the U.S. Department of Justice, Department of Homeland Security and Department of Defense, collectively referred to as Team Telecom, is finished. Now, we look forward to continuing our good partnership with the U.S. government as we work to implement the new National Security Agreement for the merged company after closing.

This decision brings us one step closer to merging our companies and delivering the best value and services for consumers, as well as sparking new competition in the industry. But we respect the process as the Federal Communications Commission, Department of Justice and other governmental authorities continue to review the transaction.

We must remain patient and answer questions from these agencies to help them understand the benefits the transaction would offer.

As we have discussed, there are two major components to our merger with T-Mobile — the regulatory approval process and efforts to plan for the post-closing integration of our companies. The recent regulatory developments are encouraging, and we feel confident that the evidence and analysis we submitted is thorough and compelling.

We still have work to do in order to complete the regulatory approval process, and there is much planning still underway for the integration of our companies. But we are happy with the progress we re making and expect to close in the first half of 2019.

For now, the Sprint and T-Mobile teams are busy aligning on decisions to help ensure that we will be a stronger and more competitive organization when we close this transaction.
