The reporting person owns 75% of the shares of the corporation, and he is an executive officer and director of that corporation. He

- (6) Each RSU is the economic equivalent of one share of S&W Seed Company common stock. The closing price of SANW on October 1, 2013 was \$7.76.

On March 13, 2013, the reporting person was granted 80,000 RSUs that will continue to vest in quarterly installments on the first day of each fiscal quarter through October 1, 2017, subject to the reporting person's continued service with the Company through the vesting date. Vested shares will be delivered to the reporting person on the settlement date unless the Company elects to settle the RSUs in cash or a combination of shares and cash, at the Company's discretion.
