(2) 25% of the Phantom Units vested immediately and the remaining vest ratably over three years on December 31 of each year beginning on December 31, 2018. Phantom Units will be settled upon vesting.

(3) Phantom Units vest on March 7, 2021. Phantom Units will be settled upon vesting.
