LivePerson, Inc. (the “Company”) announced that Erica Schultz, Executive Vice President, Global Sales and Markets, resigned her position at the Company on April 1, 2014.

The Company hereby reaffirms its earnings guidance, previously disclosed on February 12, 2014, for the quarter ended March 31, 2014 and for the full-year ended December 31, 2014. The Company anticipates bookings for the first quarter of 2014 to be approximately \$9 million, a 20% increase from the first quarter of 2013.
