A portion of the earned units will vest on each of 12/7/18 and 12/7/19. Dividend equivalent rights accrue with respect to these PARSUs when and as dividends are paid on HP common stock.
- On 12/07/16 the reporting person was granted 123,839 RSUs, 41,279 of which will vest on 12/07/17 and 41,280 of which will vest on (3) each of 12/07/2018 and 12/07/2019. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on the HP common stock.
