On April 22, 2008, CalAmp Corp. issued a press release announcing preliminary results for its fiscal 2008 fourth quarter ended March 1, 2008*. In the press release the Company also announced that it expects to record a goodwill impairment charge in the fourth quarter of approximately \$5.5 million that resulted from the completion of the second phase of the impairment test.
