#### ABRAXAS PETROLEUM EXTENDS EXCHANGE OFFER

SAN ANTONIO, TX (January 8, 2003) - Abraxas Petroleum Corporation (AMEX:ABP) ("Abraxas") today announced that it has extended the exchange offer (the "Offer") for its 11 1/2% Senior Secured Notes due 2004, Series A, CUSIP No. 003831AG9, and 11 1/2% Senior Notes due 2004, Series D, CUSIP No. 003831AF1 (collectively, the "Notes"), which commenced on December 9, 2002. Abraxas has extended the expiration date of the Offer until 6:00 p.m., EST, on January 8, 2003, unless the Offer is extended.

As of the close of business on January 7, 2003, \$149.8 million principal amount of the Notes had been validly tendered or guaranteed.

The Offer is conditioned on a minimum of 99% of the principal amount of the Notes (approximately \$189 million) being tendered. The consummation of the Offer is subject to certain conditions, which are described in Abraxas' Offer to Exchange dated December 9, 2002.

The notes and shares of Abraxas common stock to be issued in the Offer have not been registered under the Securities Act of 1933, as amended (the "Securities Act"), and may not be offered or sold in the United States without registration under the Securities Act or pursuant to an exemption from registration.

This announcement is not an offer to purchase, a solicitation of an offer to purchase, or solicitation of an offer to sell securities, with respect to any Notes. The Offer may only be made pursuant to the terms of the Offer to Exchange and the accompanying Letter of Transmittal.

Jefferies & Company, Inc. is acting as dealer manager and Mellon Investor Services, LLC is acting as information agent for the Offer.

Abraxas Petroleum Corporation is a San Antonio-based crude oil and natural gas exploitation and production company that also processes natural gas. The Company operates in Texas, Wyoming and western Canada.
