Item 1. Security and Issuer

Item 1 is hereby amended and replaced in its entirety with the following:

JBS USA will acquire 2,059,907 shares of Common Stock at \$4.50 per share in connection with its exercise of the Over-Subscription Privilege (the "Over-Subscription Shares). JBS USA expects the aggregate purchase price for the Basic Subscription Shares and the Over-Subscription Shares to be \$143,666,118, which JBS USA will fund with cash on hand.

The percentage of the class of securities identified pursuant to Item 1 beneficially owned by each of the Reporting Persons is based on 258,926,358 shares of Common Stock being outstanding as of the date of this Amendment, which the Reporting Persons calculated by adding (i) the 214,481,914 shares of Common Stock outstanding as of February 17, 2012, as disclosed in the Issuer's Annual Report on Form 10-K filed with the SEC on February 17, 2012 and (ii) the 44,444,444 shares of Common Stock which the Issuer will issue in connection with the Rights Offering.
