Exhibit 99.1: Press release issued December 19, 2007 in which the Registrant announced that assay results from the final 11 drill holes confirm a significant upgrade and expansion of gold and copper resources at the Mitchell deposit. Mitchell is one of three gold-copper porphyry deposits on the Registrant's 100% owned Kerr-Sulphurets project near Stewart, British Columbia, Canada. The project is well located close to the operating Eskay Creek mine and its all-weather road to Stewart. Highway #37 also offers excellent access to several possible sites suitable for processing facilities, for which the Registrant has acquired mineral tenures.
