On July 6, 2010, Hercules Offshore, Inc. (the Company) received notification from Chevron U.S.A., Inc. (the Customer) of the revocation of the Customer s invocation of force majeure for the *Hercules 120*. On June 23, 2010, the Customer notified the Company of the Customer s belief that an event of force majeure had occurred for the drilling contract covering the *Hercules 120* due to the Customer s inability to obtain the necessary drilling permits from the Bureau of Ocean Energy Management (BOEM). On July 2, 2010, the Customer informed the Company that the BOEM had issued a permit for a well in the drilling program for the *Hercules 120*, and the rig commenced operations on the evening of July 2, 2010. The Customer will be required to obtain permits for additional wells in the drilling program.
