Invesco Van Kampen Trust for Investment Grade Municipals (the Fund ) hereby notifies the Securities and Exchange Commission that it intends to redeem securities of which it is the issuer, as set forth below in accordance with the requirements of Rule 23c-2 under the Investment Company Act of 1940.

(1) Title of the class of Securities to be redeemed:

Auction Rate Preferred Shares, par value of \$0.01 per share, liquidation preference of \$25,000 per share ( ARPS ), Series A, Series B, Series C, Series D, Series E, Series F, Series G, Series H and Series I.

(2) Date on which the securities may be called or redeemed:

The ARPS will be redeemed for each series on the following dates:

(3) Applicable provisions of the governing instrument pursuant to which the securities are to be redeemed:

ARPS are to be redeemed in accordance with Section 3 of the Certificate of Vote of Trustees Establishing Nine Series of Preferred Shares.

(4) The principal amount or number of shares and the basis upon which the securities to be redeemed are to be selected:
