This constitutes Post-Effective Amendment No. 2 to Registration Statement No. 333-69145. This statement is made pursuant to Rule 414(d) of the Securities Act of 1933, as amended.

On February 15, 2002, Delta Acquisitionco Corp., at the time a direct wholly owned subsidiary of Delta Holdco Corp. ("Holdco") and an indirect wholly owned subsidiary of Newmont Mining Corporation ("Old Newmont"), was merged into Old Newmont (the "Reorganization"), with Old Newmont being the surviving corporation. As a result of the Reorganization, Old Newmont became a wholly owned subsidiary of Holdco. In connection with the Reorganization, Holdco changed its name to "Newmont Mining Corporation" and Old Newmont changed its name to "Newmont USA Limited". Pursuant to the Reorganization, shares of Old Newmont common stock were exchanged for shares of common stock of Holdco.

Pursuant to Rule 414(d) under the Securities Act of 1933, as amended (the "Securities Act"), Holdco hereby expressly adopts as its own, for all purposes of the Securities Act and the Securities Exchange Act of 1934, as amended, the Registration Statement on Form S-8 (No. 333-69145) previously filed by Old Newmont relating to the Plans indicated:

Newmont Mining Corporation Retirement Savings Plan for Hourly-Rated Employees (Registration No. 333-69145)

Accordingly, the shares of common stock to be issued under that Registration Statement shall be shares of common stock of Holdco.
