Collectively, the Reporting Persons beneficially own 4,055,000 shares of Common Stock which represent 7.8% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares of Common Stock beneficially held by 51,750,000, the number of shares of Common Stock issued and outstanding according to the Issuer s Form 8-K filed with the Securities and Exchange Commission on August 8, 2007.
